Survey Method

In February 2005, the South Dakota Criminal Statistics Analysis Center (SAC) surveyed sheriff offices in the State. A survey questionnaire accompanied by a cover letter was sent to all sheriff offices.

This was the 11th time the SAC compiled statewide management data pertaining to South Dakota sheriff offices. The results of this survey are intended to provide sheriffs with a valid means of comparing expenditures and resources of offices across the State. In addition, the results should provide the sheriffs with a substantial basis from which to justify future managerial decisions.

Currently, there are 66 sheriff offices in South Dakota (this figure does not include tribal agencies). Fifty-one offices returned surveys yielding a total response rate of 77%.

The survey instrument is a self-report completed by the sheriff or office staff. All questions were designed to be objective; however, some questions may have been subject to different interpretations. Thus, this report can only reflect summary results that are as valid and accurate as the data provided by each office.

It should also be noted that salary data throughout this report are approximations. Due to the number of personnel at any given rank and the diverse salaries relative to each officer, such approximations were necessary in order to perform overall summary calculations.

The completed questionnaires were encoded and verified by the South Dakota Criminal Statistics Analysis Center staff. General

The responding offices are arranged in ascending order by county population. This method of presentation allows the offices to make comparisons with other counties of similar size. Population estimates for 2004 are provided by the F.B.I. These estimates are derived using the most current data available from The U.S. Census Bureau. The counties are broken down by population as follows:

Five sheriff offices are the only entity housed within their building while 46 sheriff offices are housed with other offices, agencies, etc.

Of the 46 offices that are housed with others, 12 sheriff offices share personnel with the other entities housed within their building; 34 do not share personnel.

When asked if their office shares equipment with other entities housed within their building, 33 sheriff offices said yes; 13 do not share equipment.

Budget

The survey asked to specify the budgeted sources of income for 2005. The total income available to the responding agencies ranged from a low of \$61,425 per year to a high of \$5,420,680 per year. *Note: This does not include the Jail Budget (\$20,032,910) listed on page 27 for offices that have a completely distinct budget for their jails.*

Per Capita Cost of Law Enforcement

The 51 reporting sheriff offices serve counties ranging in size from 1,299 to 155,948 people. The combined total population of these jurisdictions is 630,636. By dividing the budget total expenses for all responding agencies, \$25,822,907, by the combined population of 630,636, a per capita cost of county law enforcement services of \$40.95 is obtained. The per capita cost ranged from a low of \$31.66 for the population grouping 10,000 to 19,999 to a high of \$90.99 for the population grouping of under 2,000.

New State Crime Lab and Law Enforcement Training Center

Governor Mike Rounds and Attorney General Larry Long hosted a ground breaking ceremony for the new South Dakota Crime Lab and Law Enforcement Training Center July 28, 2004, at the future site located at the intersection of US HWY 14/83 and SD HWY 1804 in Pierre, South Dakota.

Work on the \$25 million, 151,000 square foot building should be completed in November 2005. The state law enforcement center and crime lab is built on part of the 20 acres located in northeast Pierre and will contain offices of the Attorney General, the Division of Criminal Investigation (DCI), the state crime laboratory, the Bureau of Information and Telecommunications and two components of the Department of Public Safety: state radio dispatch and the Emergency Operations Center for the state.

Officer Salaries

The Sheriff's salary schedule is set by SDCL 7-12-15. The statute states: "The salary payable to a sheriff shall be established by each board of county commissioners, by resolution, but may not be less than specified in the following schedule based upon the most recent decennial federal census of population of counties. The board of county commissioners may not decrease the salary of the sheriff during the term of office of the sheriff. Any sheriff having responsibility for managing a full-time jail shall receive an additional ten percent added to the base salary listed in this section."

The Sheriffs were asked how the wages/salaries of the sworn officers (other than themselves) in their offices are determined. Thirty-five of the responding offices (69%) indicated the salaries were established at the discretion of County Commissioners. Nine (18%) of the offices reported that a salary schedule or policy is in effect. Five (10%) offices reported that salaries are determined by Union Contract, one (2%) by Law Enforcement Board, and one (2%) office indicated "other".

Sixty-one (20%) of the full-time, sworn county law enforcement officers in South Dakota are from 30-34 years old. For the 310 officers reported by offices, the gender breakdown is: 292 (94%) male and 18 (6%) female.

Education

Since October 1, 1971, the Law Enforcement Standard and Training Commission requires a high school diploma, or the equivalent (GED), before any officer may be enrolled in the Basic Training Course. This course is necessary for certification as a law enforcement officer. Individual offices may have further minimum requirements for education to get hired or to achieve specific ranks within their particular agency.

The following table depicts the highest level of education attained by the full-time, sworn personnel. This data was not available from one large agency.

Forty-eight offices (94%) of those surveyed offer a retirement program to their sworn officers. Forty-seven offices (92%) furnish basic equipment to their officers and 43 offices (84%) furnish uniforms or provide a uniform cash allowance.

Personnel Benefits

Education

Seven (14%) of the 51 responding offices provide tuition assistance for employees, 44 (86%) offices do not. Of the offices that do not provide tuition assistance, one is considering instituting a program that would provide tuition assistance to its employees.

Insurance

South Dakota sheriff offices provide a wide variety of insurance plans for officers and their families. Many offices pay for these plans in full or in part, thereby reducing the financial burden on each officer.

Forty-nine offices (96%) pay partial or full health insurance premiums for their officers. The following table illustrates the types of insurance available to the officer and his/her family and the level of premium paid by the office:

Vacation

The survey results have demonstrated great variation among the offices in vacation allotments, sick leave, and the number of paid holidays offered officers. Below is a table showing the method of accumulation for vacation time and number of agencies that utilize each method:

Sick Leave

Forty-two offices (82%) have a sick leave policy; nine offices (18%) have no sick leave policy. The amount of sick leave hours that can be earned varies from 40 to 144 hours per year. The most common policy, 21 offices, earn up to 96 hours per year.

Twenty-six offices (51%) pay a portion of unused sick time to employees when they retire. The amount that is paid back varies widely, from a range of 96 to 1,000 hours or a range of 25% to 100% of the sick leave balance.

Two offices pay a wellness benefit for unused sick time each year.

Thirty-two offices (63%) pay or compensate their line officers for overtime. Eleven offices (22%) pay or compensate their supervisory officers for overtime. Twenty-eight offices (55%) pay overtime, 26 offices (51%) pay at the rate of time and one-half, and two (4%) pay straight time.

Second Job

Forty-six offices (90%) permit their officers to work a second job, five offices (10%) do not. The following table demonstrates the limitations, if any, placed on sworn officers who routinely work second jobs (an office may list more than one type of limitation):

Vehicles

Fifty offices (98%) reported a total of 373 vehicles. There are video cameras in 218 (58%) of these vehicles. Cars (52%) and SUVs (39%) make up the majority of the vehicles. Other vehicle categories which include 4x4 pickup, motorcycle, hummer, boat, prisoner transport, bus, and van account for 10% of total vehicles. One office does not own a vehicle; the officer uses a personal vehicle.

The following table lists the number of offices per vehicle type, the number of vehicles owned or leased by those offices, and the number of vehicles with video cameras:

Twenty-three of the 51 responding offices (45%) replace vehicles per Commissioner's discretion. One office (2%) replaces vehicles based on age; seven offices (14%) replace vehicles based on mileage; and nine offices (18%) replace vehicles based on both age and mileage. One office (2%) uses another policy for replacing vehicles. Ten offices (20%) indicated that they had no schedule or policy for replacing vehicles.

Contract Law Enforcement

A section of the survey was devoted to sheriff offices providing law enforcement services to municipalities in their jurisdictions. Twenty-five (49%) of the 51 responding sheriff offices reported a total of 238 municipalities located within their counties. These offices have a contract to provide law enforcement services to at least one of the municipalities in their county. Seven sheriffs, including Aurora County, Campbell County, Jerauld County, Marshall County, Miner County, Perkins County, and Ziebach County, indicated that their offices provide

contract law enforcement services for all of the incorporated areas within their jurisdictions.

Six offices are paid based on an hourly rate with a range of \$21 to \$93. Ten offices are paid based on an annual rate, with a range of \$6,450 to \$284,109. Four offices are paid based on various per city rates. Five offices reported "other" for the method of payment.

All of the 25 offices provide year-round contract services. The number of hours per month spent by these offices providing services to municipalities range from 50 hours to 4,080 hours.

Eight offices (16%) have a contract to provide law enforcement services for federal agencies. Five of these patrol federally owned property, two provide jail administration and one office provided other services. Six of the offices provide this service year round and two offices provide it seasonally. The hours per month for year round law enforcement services range from 8 hours to round-the-clock.

Cities Not Under Contract

Forty-four offices (86%) report that a collective total of 149 cities of less than 1,000 population are not under contract with the sheriff's office. Several of those cities not under contract with the sheriff's office have on-call protection.

Warrants

Forty-eight offices served 32,560 warrants and forty-five received 33,603 warrants. As of January 1, 2005, forty-three offices reported a total of 38,111 warrants pending from prior years.

Thirty-six offices served 1,709 out-of-county warrants and received 2,043 out-of-county warrants. Seventeen offices spent a total of \$164,802 in extradition costs, averaging \$9,694 per office.

Many offices have dedicated full-time and part-time positions to the processing of warrants. Of the responding offices, 42 offices have 125 full-time officers and 9 offices have 21 part-time officers. Fourteen offices have 22 full-time civilians and three offices have six part-time civilians.

Civil Process

Fifty sheriff offices served a combined total of 53,846 civil papers in 2004. These offices collected \$914,522 in civil fees that were turned over to the County Treasurers. Forty-one offices reported collection of \$91,596 for mileage fees that

were related to the civil process. Three counties (Coddington, Pennington, and Turner) have constables to aid in the civil process.

Some counties do not record their civil process activities. Therefore, the statistics presented here should not be viewed as comprehensive totals for statewide civil process procedures. These totals are lower than the actual statewide totals would be.

Most of the sheriff offices keep track of the degree of satisfaction for executions served based on the amount of fees returned to the County Treasurer. Fifty offices returned 5,013 executions in 2004, with 47 reporting a total dollar value of \$1,430,587. Forty six offices reported 853 executions were returned fully satisfied. Thirty-eight offices reported 540 executions were returned partially satisfied, 2,910 were returned unsatisfied, and 690 executions were still pending. One county had 20 executions that could not be broken down. These 20 were included in the 5,013 total executions sum.

The degree of satisfaction should not be seen as a reflection on the quality of work done by the specific sheriff offices. Many factors are involved in whether an execution is satisfied or not, and these factors will vary among jurisdictions. One such factor includes executions that receive no action because they are in aid of garnishment.

Thirty-two offices reported collecting a total of \$401,520 in delinquent taxes. Property taxes collected for the local county total \$103,268 Mobile home taxes collected for the local county total \$143,543. Sales and unemployment taxes collected for the state totaled \$117,012. Three counties were unable to break down \$37,697 in delinquent taxes. This amount is included in the \$401,520 total delinquent taxes sum.

Sheriff Dogs (K-9)

Six sheriff offices (12%) reported owning a total of six dogs. All six offices report that the dogs are primarily used for drug detection work. One dog has been used for search and rescue.

Forty-seven offices (92%) have access to a canine from another agency. Two offices are planning to purchase a dog within the next two years.

Computers

The following table breaks down the desktop computers collectively owned by the 51 responding sheriff offices. Fifty offices (98%) own computers and have internet access.

County Jails

Jail Facilities Out-Of-County

Thirty-three (65%) of the counties responding to the survey have a formal contract with another jurisdiction to house prisoners. Five of these counties also operate their own jail facility.

The following statistics vary in that some facilities did not track some of the specific statistics. Three did not report total fees, three did not report total prisoners, and three did not track their mileage. One county does not have a contract, but reported all three statistics.

There was a total of 2,798 prisoners reported housed in another county's jail facility. The number of prisoners taken to another county's jail facility ranged from one prisoner in one county to 912 prisoners in another county. The responding counties traveled over 222,439 miles transporting prisoners. The jail fee paid for each prisoner per day ranged from \$39 to \$110. Ten counties paid \$50 per prisoner per day. The highest fees paid were for juvenile prisoner days. The total reported dollar amount spent by responding offices in 2004 for jail fees to other jurisdictions was \$1,622,335.

Jail Facilities In-County

Twenty-one (41%) of the counties responding to the survey operate a jail facility. Eleven (52%) of these facilities are classified as Regional Jail Centers; that is, they house prisoners from other jurisdictions as well as from their own. Another five (24%) have Full Jail Facilities and are able to house their own prisoners for extended periods of time (longer than 72 hours). Five (24%) of the 21 counties have Limited Holding Facilities which are limited to housing prisoners for less than 72 hours. After 72 hours of being incarcerated, the prisoners in the Limited Holding Facilities must be transported to a Regional Jail Center in a neighboring jurisdiction. One jail facility closed at the end of 2004.

Of the 21 counties that have a jail facility, 10 (48%) of them have a contract with the U.S. Marshal's Office to board federal prisoners.

Jail Budget

Twenty-one offices reported a combined jail budget total of \$20,032,910. Not all offices reported all budgeted items. The jail budgets are further analyzed for each county in detailed tables by population groupings located in the back of this publication. The authorized salary range (low to high) for the correctional officers is \$1,350 to \$58,772. The combined jail budget by category for reporting offices is as follows:

When reviewing the jail budget data, it is important to realize that some offices have completely distinct budgets for their jails, separate from their office budget. Other counties cannot separate jail costs from their total budget. In these counties, it is difficult to distinguish the expenses incurred for jail personnel from the office personnel costs, and the jail operations expenses from the office expenses, etc. Budget comparisons among these counties are difficult.

Jail Personnel

The responding 21 counties report a total of 445 employees involved in the operation of the jail facilities. Eighty-four percent (374) of these are full-time employees, with 16% (71) working part-time. The jail personnel are involved in direct custody functions, clerical/maintenance activities, and/or the administration of the facilities. Seventy-seven percent (343) of these employees are involved in direct custody functions, with titles such as correctional officer, guard, jailer, etc.

Responding agencies report that the daily jail fee charged to other jurisdictions for boarding prisoners averages \$49 per day. The range was \$37 to \$155. The collective total amount of jail fees received from other jurisdictions in 2004 was \$5,808,966. The total amount of county work release monies collected was \$1,563,221.

County jails often serve a dual function as detention facilities for the unconvicted and as confinement facilities for persons convicted of offenses. The following table analyzes this information collectively:

The average age of a jail facility is 40 years. The range was from 2-years-old to 97-years-old.

The remaining information collected for the jails is presented in tables following the "Jail Definitions". The counties are arranged alphabetically within the following categories: 1) Regional Jail Centers; 2) Full Jail Facilities; 3) Limited Holding Facilities; and 4) Counties Without Jail Facilities. Definitions are provided for clarification.

Jail Definitions

Regional Jail Center – jail facility which houses prisoners from at least one other jurisdiction in addition to the county's own prisoners.

Full Jail Facility – able to house county's own prisoners for extended periods of time (longer than 72 hours).

Limited Holding Facility – limited to holding prisoners for less than 72 hours. Any prisoner who must be incarcerated for more than 72 hours must be transported from a limited holding facility to a regional jail center.

Total Jail Personnel – includes both full and part-time employees involved in jail operations. May include personnel with other responsibilities in the office.

Receive Prisoners From – the counties a regional jail center will receive prisoners from.

Total Prisoner Days – the sum total of days that each prisoner spent in jail. For example, three prisoners for four days equals 12 prisoner days.

Out-Of-County Prisoner Days – number of prisoner days when inmates were held for other jurisdictions, such as neighboring counties and federal agencies.

Daily Fee Charged – price charged per day to other jurisdictions for boarding their prisoners.

Prisoners Received – number of prisoners received by the facility in the year 2004.

Prisoners Taken To – jurisdiction where counties with a limited holding facility or no jail facility take their prisoners.

Total Prisoners Transported – number of prisoners the county had to transport to another jail facility in the year 2004.

Mileage Transporting Prisoners – number of miles traveled by the office transporting prisoners to another facility in the year 2004.

Daily Fee Paid – price paid per day to another jurisdiction for boarding of prisoners.

Total Jail Fees Paid – total dollar amount spent by the office in the year 2004 in jail fees to other jurisdictions.

Total Jail Fees Received – total dollar amount received by regional jail centers from other counties for boarding their prisoners.

Work Release Monies Received – dollar amount of county work release monies collected by the office in the year 2004.

Training

Deputy Advanced Training

Offices were asked how many hours of advanced training are received per deputy, per year on average. Deputies received advanced training in 47 offices (92%). The number of hours ranged from a low of five to a high of 120 hours. Nine offices (18%) reported 40 hours of advanced training per deputy, per year. Six offices (12%) reported 20 hours.

Twelve offices (24%) require a certain number of advanced training hours per year for deputies. The number of hours per year required ranged from a low of 4 hours to a high of 40 hours per year.

Offices were asked if they favored a minimum number of hours of advanced training per year for deputies; 34 offices (67%) said yes. Of the 34 offices that did favor a minimum number of hours, 8 offices (16%) wanted 40 hours per year. The number of hours favored ranged from a low of one hour to a high of 80 hours.

Correctional Officer Certification

Thirty-seven offices (73%) are in favor of a requirement that correctional officers have to be certified.

Jailer Advanced Training

Offices were asked how many hours of advanced training are received per jailer, per year on average. Jailers received advanced training in 18 offices (35%). The number of hours ranged from a low of four to a high of 40 hours. Five offices (10%) reported eight hours of advanced training per jailer, per year. Three offices (6%) reported 10 hours. One office requires 40 hours advanced training per year for jailers.

Deputy Firearms Qualification

Forty-four offices (86%) require deputies to qualify with firearms. Yearly qualification is required by 33 offices (65%). Seven offices (14%) require bi-annual qualification, two offices (4%) require quarterly qualification, one office (2%) requires every six months, and one office (2%) requires monthly qualification.

Policies

Pursuit Driving

Offices were asked if they had a written policy on pursuit driving. Thirty-nine offices (76%) do have a written policy. Offices that have a written policy on pursuit driving were asked to check the option that best fit their policy. The breakdown is as follows:

- 17 Restricted criteria based on speed/offence, etc.
- 9 Decision left to officer's discretion.
- 11 Decision left to supervisor's discretion.
- 2 All vehicle pursuits are discouraged.



Use of Deadly Force

Thirty-eight offices (75%) do have a written policy on use of deadly force.

Offices were asked if they had a written policy regarding arrest for violations of protection/stalking orders. Thirty offices (59%) do have a written policy. Offices that have a written policy on violations of protection/stalking orders were asked to check the option below that best fit their policy. The breakdown is as follows:

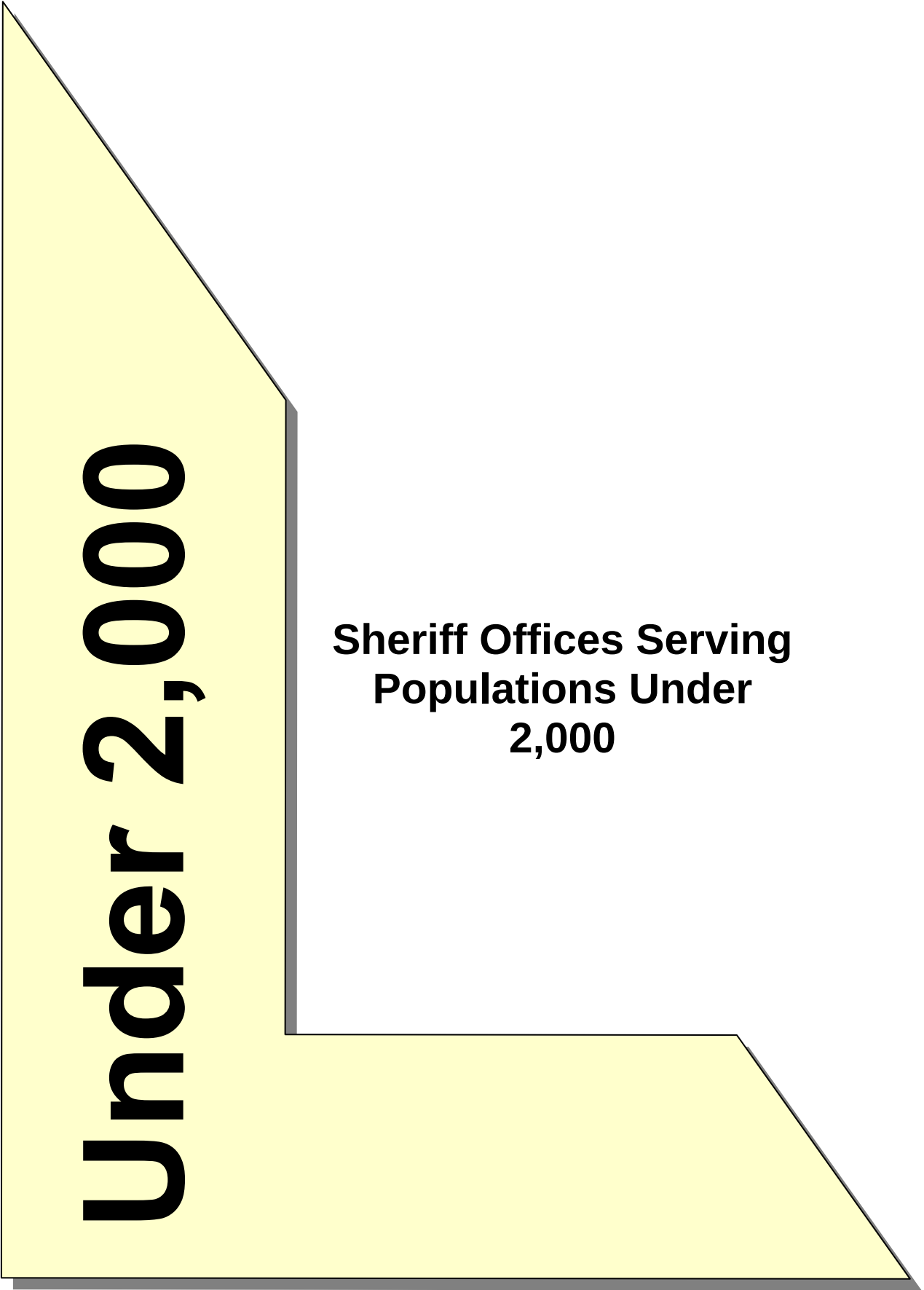
- 26 Mandatory arrest policy.

Protective Body Armor
